On Friday, Tony Sanders sent out a Resolution and Call to Action for Equity. This resolution will be presented to the school board on Monday night. I have been in ongoing conversations with the Superintendent as to what support ETA can provide with the district to address the issue of racial equity. Tony has asked for members of all five district unions, district administrators, and community members to sign this Resolution. I stand behind this resolution along with other ETA officers and ETA board members. This Resolution is in line with the already ongoing work by the school district and the District Equity Committee. The resolution is by no means the end of the conversation but a first step. The ETA will continue to develop further plans to support this work with the Equity Committee. # School Year 2020-2021 Preparations

The work for the 2020-2021 school year is well underway. I have been involved in a number of meetings with Tony Sanders, Dr. Suzanne Johnson and other district leaders regarding what the upcoming school year structure might look like. This transition team is meeting regularly to address the concerns of instruction, operations, and health and wellness.

ETA voice is at the table in these difficult discussions. I know there are so many questions and concerns about the 2020-2021 school year and there are not any answers to those questions yet. I hope to have some more information that I can share in the coming weeks about what the 2020-2021 school year holds.

Also, 200 ETA teachers are working with the district and are building individualized blueprints for teachers in Canvas. The feedback received from this past spring's virtual is being taken into account. The blueprints will be part of Canvas and be the source for all teachers. In the blueprints, you will find curriculum frameworks, rubrics, common assessments, units in your specific courses, and links to digital resources. The curriculum being used and uploaded to these blueprints are from previously adopted School Board curriculum. In addition, training is being prepared for all, teachers, support staff, students and parents to help them navigate Canvas. The work is happening fast and you need to keep watching your email for important updates.
