- B. Committee Member Survey
  - 1. Sent to 10/13 contractual committees
    - a) IC, SPED, PD were excluded
      - (1) Majority of these committees are elected members
  - 2. Around 50 committee members sent emails

- a) 60% of members did respond
- 3. Will do a deep dive into each committee based on the survey
- 4. Section directors help with filling open committee positions
  - a) TMP
    - (1) will only have one teacher lead
    - (2) 1 member is retiring and 2 others are stepping down
- 5. Teacher Lead positions have been cut
- 6. John Heiderschiedt has resigned
- C. School Board Presentation
  - 1. <u>Learning Sciences International</u> presented
    - a) Future instruction K-12
    - b) Michael Toth
    - c) Looks very familiar to what we used to do with Learning Visits etc.
    - d) 5-year plan
      - (1) First 2 years are pilot with elementary
      - (2) By year 5 will be rolled out to all schools
- D. April 6th Back to School update
  - 1. IDPH has new guidelines out for schools
    - a) Distancing requirements have changed
      - (1) 3' to 6' distances
    - b) Limit of 50 in a space has changed
  - 2. Tony Sanders sending out a message on Friday, March 12, 2021, that things will be changing for schools No details at this point
    - a) Intent is April 6, 2021, back in the building design of some sort
      - (1) Possible Prek but K-12
      - (2) 5 days, all day for hybrid learners
        - (a) Not changing schedule or surveying parents
      - (3) How does this look at the Small Schools model? Hybrid? Elementary? Secondary?
      - (4) Concurrent teaching?
    - b) Possible board presentation on Monday, March 15, 2021
    - c) Have to give 3 weeks notice before a change can be made
    - d) April 23rd day may be moved to March 22nd
- E. Transfer Reassignment
  - 1. Process has started
    - a) Based on ISBE rating, years of service, and certification
  - 2. Anticipation that there will be a drop in enrollment for the next 5 years
  - 3. 3rd BOE meeting is for any mistakes that have been made, more RIFs, or needing to recall someone
