I. Approval of the Minutes

VI. Leadership Updates

- A. Committees: The Board of Ed communication team is up and running. MTSS is meeting this month. The compensation committee is at a standstill. The PD committee and the TAP oversight committees are taking the committee member training.
- B. Sections: There is confusion about the requirements for SIP and the changes that are being mandated. Rich will check into why the changes are being made. Information about the supervisory rates are located on the ETA website. The lack of subs continues to be an issue. Grade level meetings are voluntary. Para positions are not being filled. PP Days are teacher choice and admin cannot mandate

teacher attendance at any training. Teachers are being told to do interventions without any support. Eureka math is a resource, not a curriculum. The dual language 90% staffing is determined by central office and attempted to be maintained at the building level. There is a limit of 70%/30% of special ed students in a room. Speech only students are not counted. SEC is not responding to personal communications. Parent complaints should follow the contract language. Special ed issues continue to go unanswered. Teachers who are the victims of assault by a student should file a police report.
