 - a. Professional Development Funding: PD money is available for members through Region money. The election for IEA RA is on Nov 29th.

- b. IEA Board Update: The ESSA act requires student growth for the states accountability plan. It is not the same at the teacher evaluation process.
 Substitute teacher shortages are happening all across the state.
- c. Grassroots Political Action: The school board election is this spring with 3 seats up for election. Candidate information and meet the candidate session information will be coming soon.
