- One step was frozen in 2010
- One step has currently not been given for this year and is still being negotiated at bargaining
- Example: A member in their 20th year in U-46 would be on step 18, having one step frozen from 2010, and one step not given for 2018

#### **School Department Contract Language**

#### School/Department Committee

- Section 2.54, Pages 6 and 7 of The Elgin Agreement
- Participants are elected by ETA Members and serve a term of one year
- Members hold the position of chair and secretary
- Meets minimally monthly, more often as team feels necessary
- Meeting day and time are reached through consensus
- Concerns and issues collected from the building
- Agenda is created and shared two days before the meeting
- Decisions are reached through consensus
- Minutes are shared two days after the meeting
- Discipline policies, building usage, Appendix F, staffing, excessive teaching load, budget
- Personnel is NOT a topic for SD
- Resources available at theeta.org



#### **SIP Contract Language**

#### School Improvement Committee (SIP)

- Section 15.1 on Pages 56-57 of The Elgin Agreement
- Participants are elected by ETA Members and serve a term of one year
- Meets minimally twice a year, more often as the team deems necessary
- Meeting days and times are reached through consensus
- Minutes will be shared with staff within two days of meeting
- Agendas for staff meeting and School Improvement Days Planned
- PPD agendas collected and used for data purposes
- Decision are reached through consensus



#### Consensus

Consensus decision-making is a group decision-making process in which group members develop, and agree to support a decision in the best interest of the whole. Consensus may be defined professionally as an acceptable resolution, one that can be supported, even if not the "favourite" of each individual. It has its origin in the Latin word consensus (agreement), which is from consention meaning literally feel together.
