Filing of the ULP

- The Unfair Labor Practice has been filed with the Illinois Labor Relations Board
- We had a 180 Day window to file and we did prior to the deadline to protect the contract.
- The ULP is being held in abeyance as we continue to bargain.

- ETA is looking to collaborate to revise the current SD handbook and create an SIP handbook




Staffing and School Department


- Decision regarding staffing should be discussed at School Department.

- Distribute any NEA/IEA/ETA materials that you receive.

February Responsibilities
