# Motion: Approval of the Budget for the Elgin Teachers Association for 2020-2021



#### **ETA Budget Executive Summary**

In accordance with ETA Bylaws, Article 5, Section 3, Item 9, the ETA President will, "Prepare and recommend an Association program and budget for adoption by the Representative Assembly at its September meeting." Further in Article VII, Section 3, Item 3, the Representative Assembly will, "Enact an annual budget for the Association at the regular September meeting." In addition, the Representative Assembly, "Set the annual dues for Active and Honorary membership in the Association and determine the rights and responsibilities of Active and Honorary members." Article VII, Section 3, Item 7.



#### **Executive Summary Continued**

The following reflects changes in the main Budgeting Categories:

I. Affiliate Participation: No Changes Based on 2600 members same as last year

II.Contract Development Reduced external printing \$5000

III. Executive department: .We added \$2000 for minority director. We updated the honorarium and president's salary to reflect an increase in base salary. First Vice President Association Leave increases to 2 days a month from 1 day per quarter. Increase of \$200 in postage

Audit: Increase of \$10000 to cover audit of 2019-2020.

IV. External Operations: No changes

V. Governance: Board of Directors and Elgin Community College rental costs reduced for BOD from Aug through Dec. Reduced costs of ECC by 50%

Member training and professional development now includes budget of \$4000 to support training for teachers during Distance Learning

VI. Internal Operations: Increased budget for technology subscriptions: Constant Contact, Zoom, Survey Monkey, Google Suite, QuickBooks. \$4000 No other changes
